# THE DELEGATE'S ROLE AT THE GENERAL SERVICE CONFERENCE – WHAT IS IT?

Before looking at the Delegate's role, we need to first define the General Service Conference. From the Service Manual: "The Twelve Traditions make clear the principle that AA, as such, should never be organized, that there are no bosses and no government in AA. Yet at the same time, the Traditions recognize the need for some kind of organization to carry the message in ways that are impossible for the local groups," such as publishing uniform literature, providing public information resources, helping new groups get started, producing an international magazine, and "carrying the message in other languages into other countries.... The Conference structure is the framework in which these 'general services' are carried out. It is a method by which AA's collective group conscience can speak forcefully and put its desires for worldwide services into effect. It is the structure that takes the place of government in AA, ensuring that the full voice of AA will be heard and guaranteeing that movement-wide services will continue to function under all conditions."

The first conference was held in New York in April of 1951, with 37 delegates from Canada and the US attending. Also in attendance were 15 Board members and 10 General Service Office and Grapevine staff. The year 2004 marks the Conference's 54th annual session. The 54th General Service Conference will have approximately 135 voting members from the US and Canada. There will be 93 Delegates, one from each Area of the Conference, each assigned to at least one Conference Committee. Our Delegate, Nancy K, is serving on the Policy and Admissions Committee. Her committee will have a lot to do at the Conference. Nancy will report to the next Area Assembly the details of the Conference and her Committee's work.

The Conference functions on the committee system and has eleven standing committees and two secondary committees, with eight or nine members from different regions, if possible, to provide the broadest spectrum of thought. Committees usually have an even distribution of first- and second-year delegates. It is in the Conference Committee meetings that a great deal of the Conference work gets done. The better the committee's job, the better the information reported to the Conference as a whole. The Conference Committee is the heartbeat of the conference. Reaction by the Conference can be one of prompt acceptance or prolonged dissertation,

depending on how well the Committee addresses its assigned agenda items. If the Committee leaves unanswered questions, the Conference is likely to, as it should, work a little harder to look for answers. The Ninth Tradition says "AA, as such, ought never be organized: but we may create service boards or committees directly responsible to those they serve." It is in the Committee that the collective voice of the groups is heard and acted on.

The Conference week is a very busy time for its members. Most will arrive on Saturday, get their room assignments, meet other Conference members, attended a Delegates-only meeting, and somehow find time to eat. Sunday features the first of the regional meetings, a combined meeting with the committee's corresponding Trustees committee, a banquet with several speakers, and the official opening of the Conference itself. Some Conference committees will meet on Sunday for the first of many sessions.

The committees generally meet on Monday and Tuesday. They discuss their agenda items and draft their reports, which may include recommendations for the whole Conference to act upon. Committees present their reports from Wednesday through Friday. Committee reports can often stimulate hours of passionate discussion and debate. Ultimately the conscience of AA as a whole prevails.

The Committee reports are presented to the entire Conference. Each item can have one of three possible outcomes: a recommendation, a consideration, or no action at all. The difference between recommendations and considerations is that, when passed with a substantial unanimity (2/3 of the Conference or more in favor), recommendations become Conference Advisory Actions. These become binding when approved by the General Service Board. Considerations are forwarded to the appropriate Conference Committee and may or may not be acted upon. When no action is recommended, the item typically dies and isn't heard from again.

In addition to her Committee work, Nancy will attend two Regional lunches, where much of the Region's business is conducted. She will also attend two Delegates-only meetings, usually general sharing sessions. But sometimes, new ideas are fostered in those meetings. One such idea began in the Delegates-only meeting in 2000 and later became a reality—the

### Correctional Facilities

- Agreed to include the statement on AA's Singleness of Purpose in the *Correctional Facilities Workbook* and unanimously recommended that the trustees' Committee on Correctional Facilities consider including the statement on AA's Singleness of Purpose, which follows, in the pamphlet *A Message to Correctional Professionals*:

*"Some professionals refer to alcoholism and drug addiction as 'substance abuse' or 'chemical dependency.' Nonalcoholics are, therefore, sometimes introduced to A.A. and encouraged to attend AA meetings. Anyone may attend open AA meetings, but only those with a drinking problem may attend closed meetings."*

### Grapevine

- Expressed gratitude for the AA Grapevine Corporate Board's final report on placing *Grapevine* items for resale in non-AA outlets and unanimously recommended to allow the widest distribution of the *AA Grapevine* and *La Viña* to all purchasers, while guarding against affiliation with any outside enterprise,
- subscriptions to the *AA Grapevine* and *La Viña* magazines be issued only by the AA Grapevine, Inc., or by AA trusted servants directly; and

- the AA Grapevine, Inc., adopt standardized sales practices and pricing for all purchasers. This recommendation is to clarify the 1993 Advisory Action, which states "the Grapevine Corporate Board not actively pursue the placement of *Grapevine* materials for resale in commercial (non-AA) outlets."

- Unanimously recommended that the *AA Grapevine: Our Meeting in Print* pamphlet be revised to include the proposed references to *La Viña* and *La Viña* Representatives, wherever the *Grapevine* magazine and its representatives are mentioned.
- Unanimously recommended that the *AA Grapevine Workbook* be designated as service material and be reviewed on an annual basis.

### International Conventions/Regional Forums

- Recommended that an anonymity-protected photograph of the flag ceremony be taken at the 2005 International Convention.
- Recommended that the General Service Conference support the General Service Board Policy as amended on November 2, 2003, which reads: "Whenever a discount or subsidy is that which would be offered to any other organization of similar size requiring a purchased service or product of similar character and magnitude, for example, convention rates at hotels, it may be accepted. Whenever a discount or subsidy is partly or in total offered because we are Alcoholics Anonymous, it must be declined."

NOTE: The original Board policy text contained the letters "i.e.," which were replaced with the words "for example." The General Service Board amended the policy because "for example" more accurately reflected the intention of the 1989 trustees' Committee on International Conventions/Regional Forums. The 1999 General Service Conference supported the Board's 1989 policy through an Advisory Action.

The committee noted the Additional Consideration of the 1999 Conference Committee on Finance, which reads: "The committee unanimously recognizes that the acceptance of discounts or subsidies in the form of cash causes discomfort to some members of our Fellowship. The committee suggests that any future negotiations regarding International Convention discounts or subsidies be carried out with this in mind."

### Literature

- Recommended that the Publications Department rewrite the pamphlet *Too Young?* with changes to layout and style as determined by Publications, targeting the ages of 11-17, and present the revised draft pamphlet to the 2005 Conference Literature Committee following review by the trustees'

# WORKING FROM THE OWNERS MANUAL

BILL M, HOW IT WORKS GROUP

My name is Bill, and I am a grateful alcoholic. I am here to report that alcohol has not been very good to me, and I have not been very good to myself. That started long before alcohol became the game. The sad truth is that not being good to myself made it easy not to be good to you or anybody else. I, like many, started drinking at a young age.

The more I drank, the better I got at it and the longer I drank. And often, the angrier I became. This behavior was becoming habitual and destructive. A typical night of drinking for me involved getting kicked out of a bar, wandering on to another, getting kicked out of that bar, then locating two or three of "Baltimore's finest" with nightsticks. That is a brief description of my life until almost three years ago.

Since then I have become willing to go to any lengths, to be honest with myself and others, and to remain open-minded enough to listen sometimes. When I returned to AA this time (after nearly 20 years around the fellowship), I finally heard it said that this program was about progress, not perfection. I have been making progress, not attaining anything near perfection.

I thank God for sponsors, especially the one God put in my life. Once I reached a point of surrender and humility, and at the suggestion of a friend of mine, I asked someone to be my sponsor. He has been there to help me learn about the Steps, Traditions, and Concepts. But most of all, he has been a stable example of something I want out of my life. Now don't get me wrong; he is not perfect as a sponsor. I feel he is perfect for me, though, and maybe for some others he sponsors. All of us who have sponsors should be thankful.

I have lightly touched upon a couple of the important parts of this program of recovery for me. This is much different than the program I used to work – Bill's program. The end of Bill's program came when I stopped breathing – you know, dead. AA and sober people have shown me how they live, and I am learning how to live one day at a time. Action and more action, that seems to be the key to a program for staying sober, for living, that works. There are so many different and special kinds of action, truly something for everyone.

Sometimes when I hear people share their experience, strength, and hope, the story they tell parallels what I have done and what has happened to me. At other times, all I can do is listen for the similarities. But either story reminds me of the experience of using and abusing alcohol (for me, mostly abusing). The part that often changes for me is the recovery part of my story. It is not always easy, and many people I have met along the way tell me to expect a few bumps in the road.

For me the Big Book of *Alcoholics Anonymous* is chock full of information and step-by-step directions; it is the owners manual. A wealth of knowledge lies inside it, but I can't just let that knowledge lie there. The only way I've learned to get the knowledge from it is to read it, to participate in Big Book studies, and to talk to my sponsor and other sober alcoholics about it. And I have to put that knowledge to work through action. This seems to work, where Bill's program didn't. My hope for you is that you and your Higher Power work together the rest of your days.

Concepts were added to the Big Book. Nancy will also sit in on reports from the General Service and Grapevine offices. These reports will give her, and subsequently us, the nuts and bolts of both operations.

Conference week isn't all work; there is some time for play. NERD (Northeast Region Delegates) night out is always a hit, and many can find a night or two for little sightseeing or taking in a local meeting. On Friday night, many will attend a ball game if the Yankees are in town, and Saturday on even years means a trip to Stepping Stones, Bill and Lois' home from 1941 until their deaths. One of the last jobs that

Nancy will have at the Conference will be to stuff copies of the early edition of *Box 4-5-9* into many an envelope at breakfast, so she can get them in the mail before noon.

A big part of any Delegate's job is to be a communicator. They need to hear the voice of their Area and somehow blend that voice with all the other voices of the fellowship into working solutions for all of AA. They also need to be able to hear the needs of AA and somehow communicate those needs to the Area, so the Area can express its views and communicate them back through the Conference. It's a continuous process that has been going on for 54 years so far and, hopefully, will continue for as long as the suffering alcoholic still needs us.

Literature Committee.

- Recommended that the Publications Department update and shorten existing stories, wherever appropriate, in the pamphlet *Young People and AA*, and that the trustees' Literature Committee add new, younger-age stories solicited from the Fellowship to reflect current experience, and present the revised draft pamphlet or a progress report to the 2005 Conference Literature Committee.
- Recommended that a draft Spanish-Language 3rd Edition Big Book, *Alcohólicos Anónimos*, be developed by the trustees' Literature Committee and that a progress report be brought back to the 2005 Conference Literature Committee, in keeping with the trustees' recommendations on contents, process and story solicitation, as follows:

### O Contents

- The 3rd Edition Spanish-Language Big Book to be similar in page count to the English 4th Edition Big Book.
- The first 164 pages of the Big Book, *Alcohólicos Anónimos*, the Preface, the Forewords, "The Doctor's Opinion," "Dr. Bob's Nightmare," and the Appendices will undergo a complete review to assure accuracy of translation and consistency of style and tone throughout the text. As in translations of all languages, the Publications Department strives to reflect the best possible translation of Bill W's writings and does not require Conference approval.
- Personal Stories: Retain selected stories from current Spanish-Language 2nd Edition. Select stories from AA's *La Viña* magazine. Select new stories from Spanish-speaking membership. Stories to be designated to three main sections similar to the English 4th Edition Big Book.

### O Story Solicitation

- Within the United States and Canada and internationally to Spanish-speaking countries.

### O Story Selection Process

- To be under the direction of the trustees' Literature subcommittee on the 3rd Edition Spanish-Language Big Book.
- Story selection subcommittee: All bilingual, Spanish and English; Spanish Editors; Spanish-speaking Staff Members; Chair to appoint subcommittee members from the Fellowship.
- Basic Selection Criteria: To use the same criteria as the English 4th Edition Big Book based on Bill W's recommendations. Each story must, as Bill W recommended, reach out to the newcomer who is still looking for the AA solution. Each story must be a standard AA story that tells what it was like, what happened, and what it is like today.

- Recommended that the text on page 11 under the heading "May a newcomer have more than one sponsor?" in the pamphlet *Questions and Answers on Sponsorship* be removed and replaced with the following text:

*"Many feel it is best for a newcomer to have only one sponsor. Choosing one sponsor helps to avoid the precarious practice of a newcomer going from sponsor to sponsor seeking the advice he or she wants to hear. However, some newcomers benefit from more than one sponsor. Here the newcomer shares in a wide range of experience and hears a great variety of ways to use the AA program. In addition, this is a means of averting the crisis mentioned in the preceding question—it is unlikely that two or more sponsors would be unavailable at the same time;"*

...and the sentence "Again, the answer is yes." be removed from the paragraph under the heading "May a newcomer change sponsors?" on page 11.

- Recommended that the trustees' Literature Committee

broaden the section titled "Service Sponsorship" on page 28 in the pamphlet Questions and Answers on Sponsorship to reflect current shared experience and present a revised draft to the 2005 Conference Literature Committee.

### Policy Admissions

- Recommended that the 57th General Service Conference be held April 22-28, 2007, since these dates do not conflict with any major religious holidays.
- Recommended that the use of personal computers at General Service Conferences be approved in keeping with the "Guidelines for PC Users at the General Service Conference" contained in a report from the trustees' Committee on the General Service Conference.

NOTE: The Conference Coordinator will continue to notify Conference members annually of the availability of up to 24 spaces complete with power outlets for the use of personal computers at the General Service Conference. If the number of requests for the use of personal computers exceeds 24, the Conference Committee on Policy / Admissions will review the Guidelines.

- After extensive discussion, the committee expressed gratitude for the hard work involved in preparing this request and unanimously recommended that the request from Area 15, South Florida, Bahamas, US Virgin Islands, British Virgin Islands and Antigua to create a new Delegate Area be denied. The committee suggested that the Area reconsider this request and explore alternatives at the Area level to address the challenges of the General Service structure in Area 15.
- Recommended that the current practice for viewing or examining all materials other than service material submitted for Conference approval be continued, adhering to the principle of the "right of decision" throughout the Conference process.

### Public Information

- Unanimously recommended that the tag line on all radio PSAs be changed from "Look us up in the phone book" or "Phone or check your newspaper," to the tag line currently in use in the television PSAs "Look us up. Check the phone book, newspaper or aa.org."
- Recommended that:
  - The AAWS Board should continue to manage the Web site through its Services Committee.

- Any correspondence, requests for changes, or requests for reports on the Web site would continue to be responded to by the AAWS Board.
- The AAWS Board would be responsible for preparing a quarterly report to the trustees' Public Information Committee for their review. The report would include the following information:
  - Changes to the Web site
  - Updates on Web site activity
  - A summary of requests or correspondence from the Fellowship regarding the Web site and a summary of actions taken by the AAWS Board in response to those requests or correspondence
- The AAWS Board would prepare an annual report for the trustees' PI Committee summarizing all Web site quarterly report information. The report, along with any additional comments from the trustees' Committee, would be forwarded to the Conference PI Committee for their consideration.
- The Conference Public Information Committee agenda would include a permanent agenda item, "Consider report from the AAWS Board to the trustees' PI Committee regarding GSO's AA Web site."
- As with the placing of the 4th Edition of the Big Book on the Web site, the AAWS Board may consult the General Service Conference trustees' PI Committee, the Conference PI Committee, and any other trustees' committee or Conference Committee as appropriate if major changes were to be made to the GSO's AA Web site.
- Unanimously recommended that the 2004 AA Membership Survey be conducted by Area on a random basis as was done in the 2001 AA Membership Survey

told that having a grateful heart meant being of service to this great fellowship as we carry this life-saving message. And I truly understand today that the life I save might be my own. Believe me, I've been well schooled when it come to the purpose of the AA service structure.

One of the purposes of your MGS is to help new General Service Representatives (GSRs) and District Committee Members (DCMs) learn their roles in serving groups, districts, the Area, and AA as a whole. I learned that AA depends on group participation through GSRs and DCMs to formulate the collective conscience of the Area. It is through our Area Assemblies and Committee meetings that we are able to inform our Delegate about issues that affect our local groups and AA as a whole. GSRs and DCMs also play an active and important role in our Area committees.

MGS' committees, such as Treatment, Corrections, Public Information, Cooperation with the Professional Community (just to name a few), carry AA's message to the public and to the professional who comes in contact with the sick individual. To put it another way, our committees "bridge the gap" between the fellowship and the community they serve.
