# **Delegate Report**



Welcome to our August Assembly, especially those new to Area Service. We need you! This is our first Assembly since I provided my report back from the General Service Conference. Since then I've been busy traveling around our Area, both physically and

virtually, giving shorter versions of that report. Today I'll provide updates on many of the various actions approved at our General Service Conference. For those that may have missed the May Report-Back Assembly the slides and other documents are posted for download on our website, marylandaa.org.



## **New & Exciting**

The initial trial of the Young Peoples Video Project was a great success, and it has been made an ongoing effort. Look for the initial videos to be released on various platforms in the near future.



A digital option is being added to the 2025 International Convention, providing anonymity-protected, encrypted, digital access to the Friday night meeting (including the flag ceremony), and the Saturday and Sunday Big meetings, at a fee to be determined. A "flag ceremony only" option will continue to be available online for free.

**Call for Stories** – The trustees' Literature Committee has opened a call for recovery stories for the pamphlet "A.A. for the Native North American Alcoholic." The pamphlet update will include current stories of recovery and a new title that is respectful and inclusive. They are seeking stories of recovery from all Indigenous communities in the AA structure in the United States and Canada. Deadline is October 31, 2023. ## General Service Board (GSB) & General Service Office (GSO)

Our General Service Board met the final weekend in July. Throughout the weekend they began implementing the Advisory Actions approved at the General Service Conference. The print and anonymity-protected digital versions of the Conference Final Report are due in early September. The digital version will be posted on AA.org for the first time.

During the week prior to Board Weekend the Trustee's Nominating Committee interviewed ten candidates for General Service Board Chair. Recommendations for second interviews were made to the entire GSB, and in-person interviews of the three candidates moving forward in the process will be held during October's Board Weekend. 116 qualified persons were sent inquiries about availability and willingness to serve. 32 responded, 10 being willing candidates (average in the past has been about 20). One of the ten initial candidates is a past Class A Trustee. The Board approved a \$15K expense for the search.

At this year's conference there was an Advisory Action requiring the GSB to undertake an inventory. The Advisory Action stated in part, "To assist the Board in this endeavor, the 73rd General Service Conference will establish a working group to aid the General Service Board in formulating possible inventory questions." This working group has been developed and input received from the selected Delegates. Further input is being gathered from non-Delegate members of the working group.

Our GSO is updating the group database, thereby improving communications. If you are curious about the status of your group, contact your DCM, our Registrar Jeanine, or me.

The Google Ads discounted search results effort has been discontinued. Google has updated their policy and they no longer allow "mutual support organizations" to participate. Frequently asked questions (FAQs) are scheduled to go live on aa.org this summer with all 102 FAQs fully translated into 3 languages.

<u>PAI Submission Forms</u>: The Trustees Conference Committee reviewed a draft of an online PAI Submission form for 74th GSC and offered minor suggestions. The committee noted user-friendly features of the online version including A.A. resources that connect submitters with their local districts and areas for the opportunity to participate in local group conscience discussion. The committee agreed to only post instructions on how to access the form and suggestions that can foster focus on developing a group conscience.

## **Financial Update**

This information (unaudited) is as of June 30, 2023:

- Contributions: \$4.84 million (102% of YTD budget)
- Literature Sales: \$7.88 million (108% of YTD budget)
- Literature Margin: \$4.1 million (112% of YTD budget)
- Expenses: \$8.98 million (101% of YTD budget)
- Prudent Reserve: 7.11 months

At the July General Service Board Meeting a reforecast budget was approved. The reforecast budget has an operating deficit (after depreciation) of \$292,931 compared to a surplus of \$505,841 in the January approved budget.






Progress has been made regarding translation licensing inquiries. The backlog of 965 requests was down to under 200 as of Aug 16th. We should be current by mid-September.

### **Northeast Region Update**

We have a new Northeast Regional Trustee (NERT), Ken T. from Area 31, Western Mass. At the recent General Service Board Weekend he attended the new trustee orientation

The Northeast Region AA Service Assembly (NERAASA) committee, along with our trustee and regional delegates, have been discussing options for rebuilding the NERAASA prudent reserve. While the 2023 event was well attended, with 1,071 attendees, expenses were higher than budgeted for, resulting in a shortfall of \$4,324.83. This resulted in funds being withdrawn from the reserve. Options being considered include asking Areas to provide funds, raising registration fees, and reducing expenses.

NERAASA 2024 will be hosted by Area 59 Eastern PA in Hershey PA. Feb. 23-25, 2024 . Registration is now open at NERAASA.org/register.

On July 26, 2023 our PSA's began showing in 2,193 pharmacy locations nationwide. Six thirty-second A.A. video PSAs in English and Spanish are in rotation. These videos will have approximately 11,000,000 monthly showings. During August they will begin airing in 2,500 doctors offices nationwide.
