### **General Service Board News**

Highlights from the General Service Board quarterly meeting on 10/30/17:

- The Trustees' Literature Committee agreed to forward a number of Agenda Item proposals to the Conference Coordinator, including adding several items to the Big Book, developing pamphlets for atheists and agnostics, and revising a handful of existing pieces of literature.
- The Trustees' Committee on International Conventions/Regional Forums agreed to participate in the 2018 Al-Anon International Convention in Baltimore on July 5-8.

### **Conference Committee Assignment:**

For the next two years, I will serve on the Conference Grapevine Committee. We have already held a joint conference call with both the AAGV Corporate Board and the Conference GV Committee. With so many compelling items on our agenda this year, I am very grateful that in Area 29 we have three Past Delegates with a total of 13 years of experience on AA Grapevine Committees at the Conference or Trustees' level.

## A.A. World Service, Inc. News

**Corrections:** The Fall 2017 issue of *Sharing from Behind the Walls* was doubled from two pages to four pages to allow more inmate sharing.

**Finance:** AAWS has requested time at the 2018 GSC for a presentation with the tentative title: A.A. Principles and Fiduciary Responsibility. Total revenues for Jan-Sept 2017 were \$1.2 million over budget, about half from literature sales and slightly over half from a significant increase in group and individual contributions. If the trend continues, we may even reach the goal of becoming 100% self-supporting through our own contributions.

- **G.S.O. Desk Assignments:** A confidential list of the Service Desk assignments at the General Service Office is available in hard copy. Please use these contacts to communicate directly with your GSO.
- **I.T.:** The security for GSO's Fellowship New Vision (FNV) database has been reconfigured, and a training manual has been sent to all Area Registrars.

**Public Information:** Local P.I. committees can now link broadcasters to a page on *aa.org* where all current video PSAs can be downloaded in HD Broadcast quality, on demand and without cost to the broadcaster or the local committee.

Area 29 Contributions to GSO: The Area 29 Quarterly Contribution Reports provided by AAWS for the 4th Quarter of 2017 were emailed to all DCMs on February 6. If you did not receive a copy, be sure to let me know. Please share these reports with your GSRs! The reports provide an opportunity to discuss the importance of self-support in maintaining our services. Total Area 29 Group contributions reported in 2017 were \$99,475.95, with 432 (43.53% of all) groups contributing, an improvement over 42.83% of groups in 2016. Kudos to District 41, which had contributions from 16 of 22 groups (72.73%).

Out of a total of 997 Area 29 Groups in GSO's Fellowship New Vision database, 835 are listed as active, meaning they have a registered GSR or Group Information Contact with a postal mailing address, and 162 Groups are listed as Unknown, meaning there is no current Group contact information in the database. It is vital that DCMs review the report to make sure all the Groups in your District are listed correctly. If there are any updates, please contact Area 29 Registrar Ray T. with the correct information. He will post it in the FNV database immediately. Please do NOT contact GSO or send information directly to them; that will only impede progress. Now is the time for us to get our records straight so we can move forward in service during the rest of Panel 68.
