New & Exciting

With a new year having started our Area Chair, Brigitte F., has released the 2022 Calendar of Area Events. It is available on our website, <u>Marylandaa.org.</u>

Elections have been held for new Delegates and other Officers in 44 Areas other than our own. Meanwhile, at the General Service Board (GSB) and General Service Office (GSO) they are working diligently to accomplish all the work that was sent their way at the $71^{\rm st}$ General Service Conference. And preparations for the $72^{\rm nd}$ General Service Conference are well underway. It will be held April 24-30, in

Brooklyn NY. This year there will be three international observers, two from Brazil and one from Argentina.

The General Service Conference uses the committee process to allow for thorough review of agenda items, and to get the work done. There are 13 standing committees, with each Delegate assigned to one or two. I have been assigned to the Conference Corrections Committee. I will be reaching out to those I know have been involved with Corrections in recent years. And if you've been involved with carrying our message into jails or prisons, or have recently been incarcerated yourself, and feel that you can help prepare me for my conference assignment, please feel free to reach out to me.

duplicates, and others did not make it onto the final agenda for various reasons. Over 80 of the submissions were requests to undo actions taken at the 71^{st} GSC. The first year (of a 3-year trial) for the Equitable Distribution of Workload process has proven to be quite

challenging for those preparing the Conference Agenda. Nevertheless, after several early drafts were released in December and January, the final list of Agenda Items was released on Feb. 4th and sent out to all Area Committee Members. Then an updated Final Agenda was released on Feb. 9th. Background information was released on February 15th.

In 2019 Area 29 proposed an Agenda item to "<u>to create a new form of communication</u>" <u>to address anonymity on social media.</u>" We received a progress report on Feb. 11, 2022. The Trustee's Committee on Public Information will be initiating a membership survey soon, with the questions currently being finalized.

Locally, the monthly Zoom meeting with DCM's and their Alternates, begun during our last panel, will be continuing, albeit with a slightly different format. The first 20-30 minutes will be a recovery share, followed by open discussion on any topic pertinent to Districts. Meetings are at 9:00 AM the first Saturday of each month. If you are a DCM or an Alternate, and did not get an invitation, please get in touch with me.

General Service Board & GSO

Opening contributions envelopes, scanning contents, and depositing checks into the bank requires two to three full-time staff and a significant amount of time. To save time and money, they are outsourcing this work to the bank which has specialized equipment and personnel to perform these tasks more quickly and at a lower cost. The bank requires the use of a unique post office box number for this service. GSO estimates that this change will result in a savings of approximately \$162,000.00 per year. Online contributions are still preferred, and can be made at AA.org.

Due to the rise of the Omicron variant, the Office re-opening has been suspended. Although recent data seems to suggest that the latest surge in New York driven by the Omicron variant is trending downward, the Workplace Taskforce is drafting a travel policy and discussing the extent that the Office may receive visitors.

G.S.O. currently has a staff vacancy. Details regarding the position, and how to apply, can be found at G.S.O. Staff vacancy.

The Fellowship Connection Release 3.0 launched on October 14, 2021. The following enhancements requested by the end-users during sharing sessions were included in the

release: new, user-friendly Dashboard, ability to automatically provide end dates to outgoing position holders, the ability for area registrars to see when the service kits were ordered, ability to choose to receive digital or physical kits or to opt out of receiving any kits. Delegates and DCM's have read-only access.

AA In the News

Corrections Today magazine, a quarterly magazine for corrections professionals has a nice article about A.A. in the current issue. A link can be found here.

A new Corrections Correspondence System (C.C.S.) process launched September 28, 2021. The new process improves and expedites the matching of volunteers and persons in custody, provides statistics and reports, and generates personalized letters that can be sent by email to outside A.A. members and by postal mail to persons in custody. Since the launch, 267 were paired that for various reasons had been sitting in the old system. The latest edition of Box 459 has a very nice article, including contact information for those wanting to participate or learn more.

The Meeting Guide App has been updated. The newest release allows users to adjust the radius for meeting searches, and allows users to filter by in-person, virtual, or all. It also includes a News button, and a Daily Quote button, amongst other improvements.

An updated "Safety and AA: Our Common Welfare" (SMF-209 Rev. 9-21) piece of service material has been issued. Significant changes were made, including adding information regarding the pandemic and diversity and inclusion concerns. Link is here. This piece is currently undergoing additional review, with further revisions currently undergoing legal review.

Financial Update

- Literature Sales: \$11.7 million (103% of budget)
- Payroll & Benefits: \$9.3 million (98% of budget)
- Overall Expenses: \$15.7 million (99% of budget)
- Surplus YTD: \$2.0 million (267% of budgeted)
- Prudent Reserve: Approx. 8.5 months

Note: Online contributions 23.1% of total (2020 19.3%)

The annual audit is underway, and audited figures should be available for the GSC.

Did You Know?

A.A. Literature is now available in 180 countries in 102 languages with 73 different language Big Books. Soon the Big Book will be in 74 different languages, with Haitian Creole on the way. 19 other languages are in various stages of progress

Prayer & Meditation, a new book from Grapevine, is now back in stock. It contains stories by members of Alcoholics Anonymous about the many ways they pray and meditate in their daily lives. All stories were previously published in the Grapevine Magazine. Chapters include: daily routines, traditional religious practices, activities and exercise, personal techniques, the Serenity Prayer, and connecting with nature and the universe.

Free on the Inside features 50+ powerful stories by sober members of Alcoholics Anonymous who have experienced AA in prison—while either currently serving, formerly incarcerated, or as outside AA members carrying the message inside. Chapters include: finding AA in prison, staying sober inside, women helping one another, working the Twelve Steps, sponsorship and carrying the AA message into prisons.

New audio recordings of the Big Book, Alcoholics Anonymous, are <u>available on CD</u>. These new editions are available in English, Spanish, and French; and in abridged (without stories) and unabridged (with stories).

Plain and simple language Big Book translation update – The candidate pool of 18 responses to the Request for Information (RFI) for plain language interpreter-writers have been reviewed and narrowed down to six candidates. They were then assigned sample material on a work-for-hire basis. All candidates had a deadline of Jan. 3rd to submit samples for the complete chapter of "How it Works," excerpts from "The Doctor's Opinion," "There is a Solution," "We Agnostics," and "To Wives."

Mixed-Title Volume Discount Test Pilot – A six-month test pilot will run: March 15 - September 15, 2022. Orders will receive a quantity discount based on the quantity ordered for all titles combined, as opposed to purchasing a quantity of one specific title.

Implementation of "permanent" Reduced Shipping Charges – The schedule of shipping charges for A.A.W.S. literature that tested favorably during its five-month test pilot was implemented February 1, 2022.

Supply Chain Disruptions – Supply chain disruptions continue to be a challenge faced by A.A.W.S. and Grapevine. Hardcover Big Books have been out of stock, expected to be back in stock in mid-February. Grapevine's newest book "*Prayer and Meditation*" sold out during November, despite a print run 60% larger than normal. Because many members and AA offices missed out on purchasing "*Prayer and Meditation*" during the free shipping period in November and December, Grapevine will have free shipping during the month of February 2022 for this and all products.
